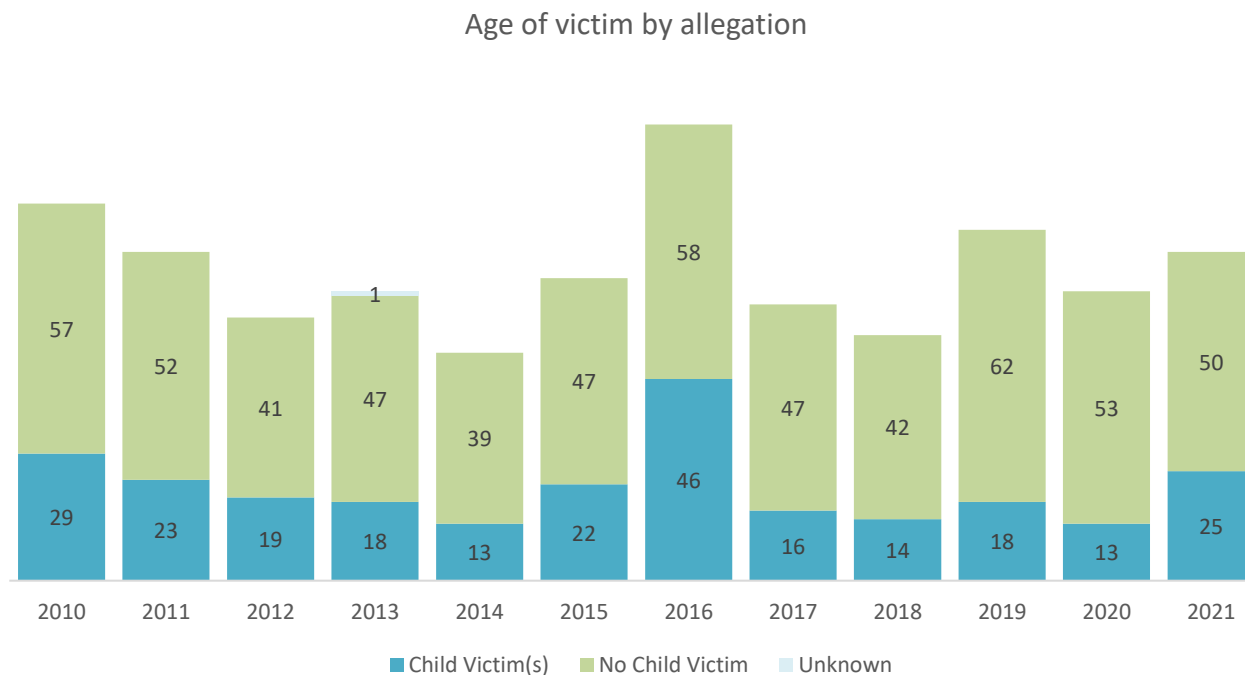

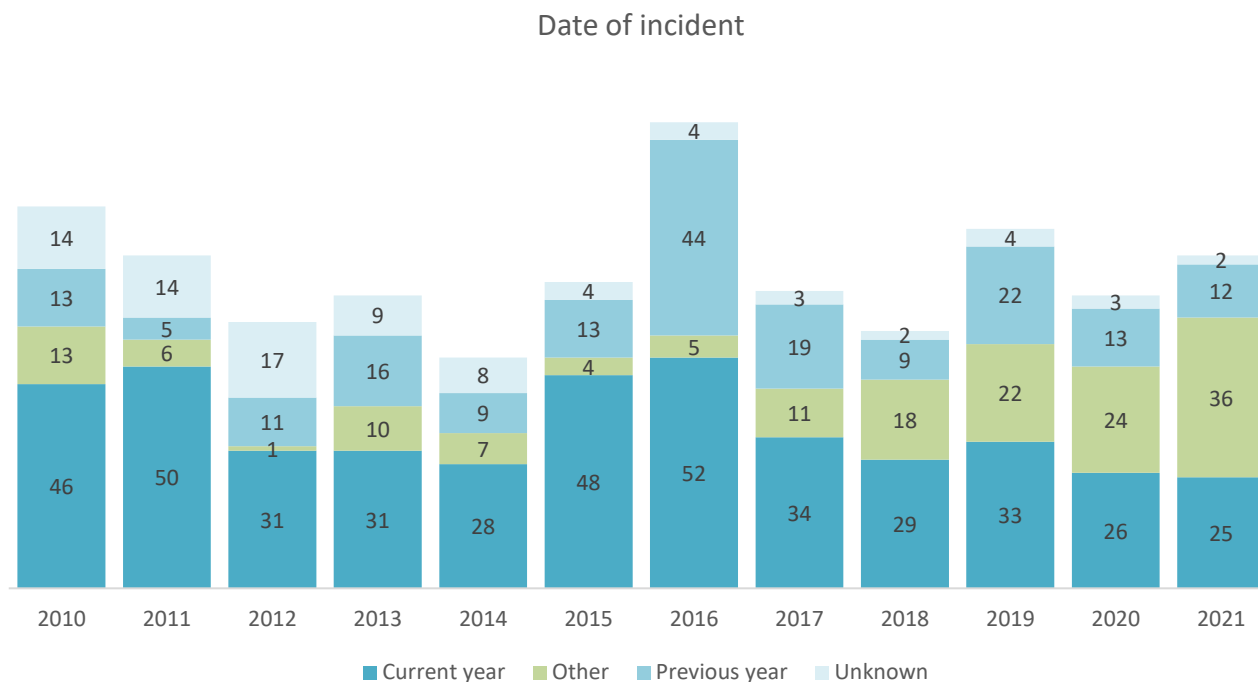

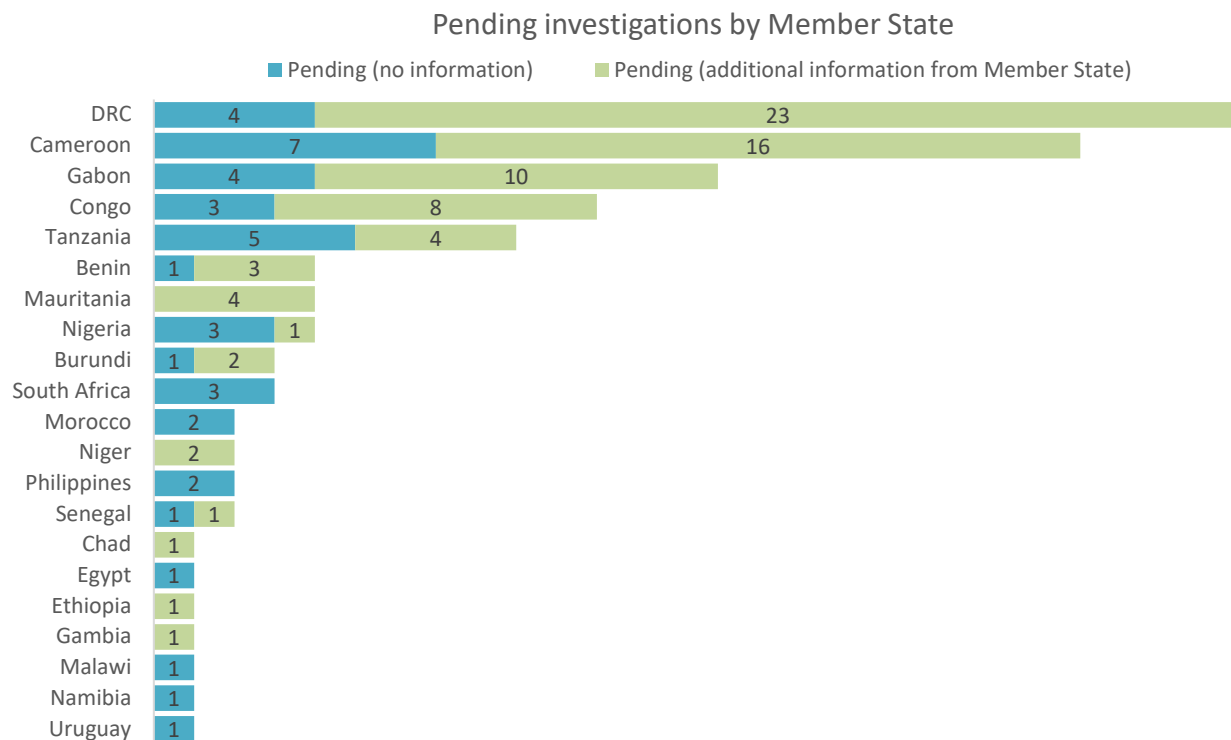

**B. Information related to paragraph 63 of A/76/702 (number of allegations by year of incident)<sup>10</sup>**



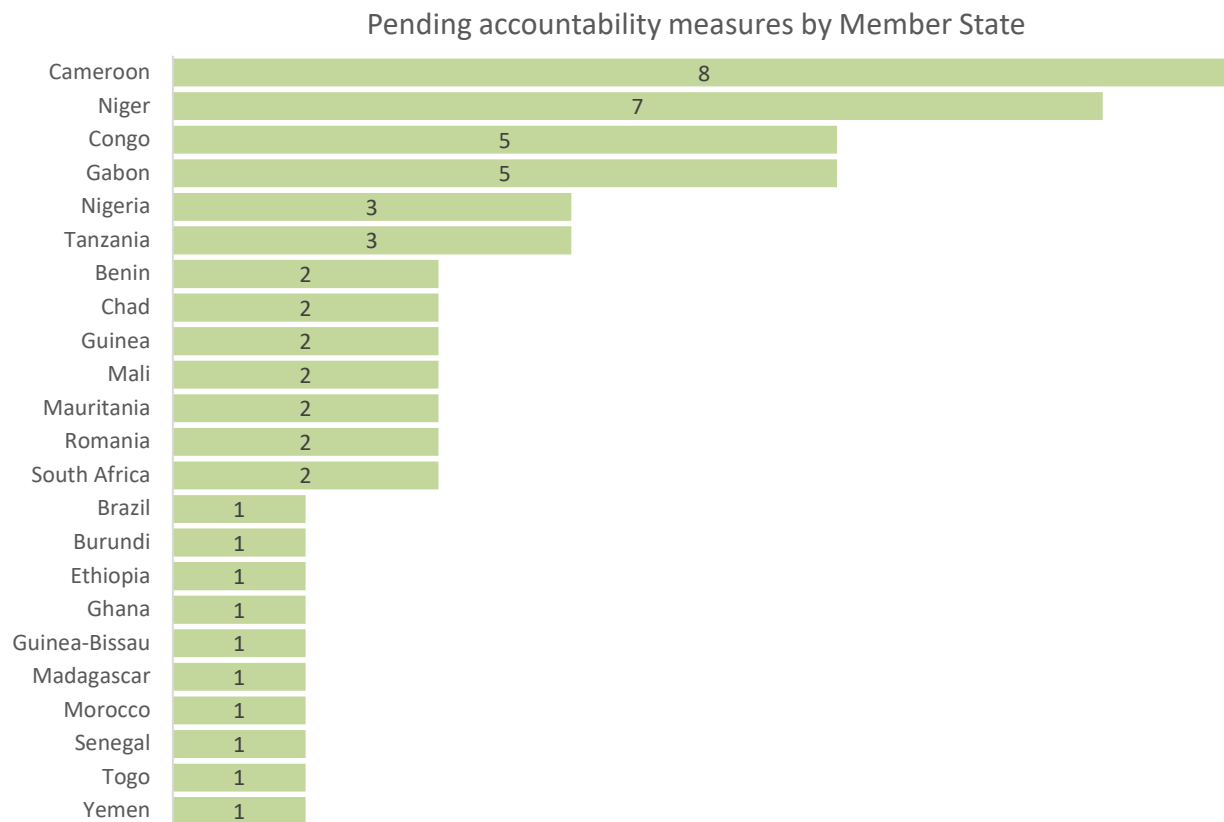

**C. Information related to paragraph 65 of A/76/702 (allegations pending investigations by Member State)<sup>11</sup>**



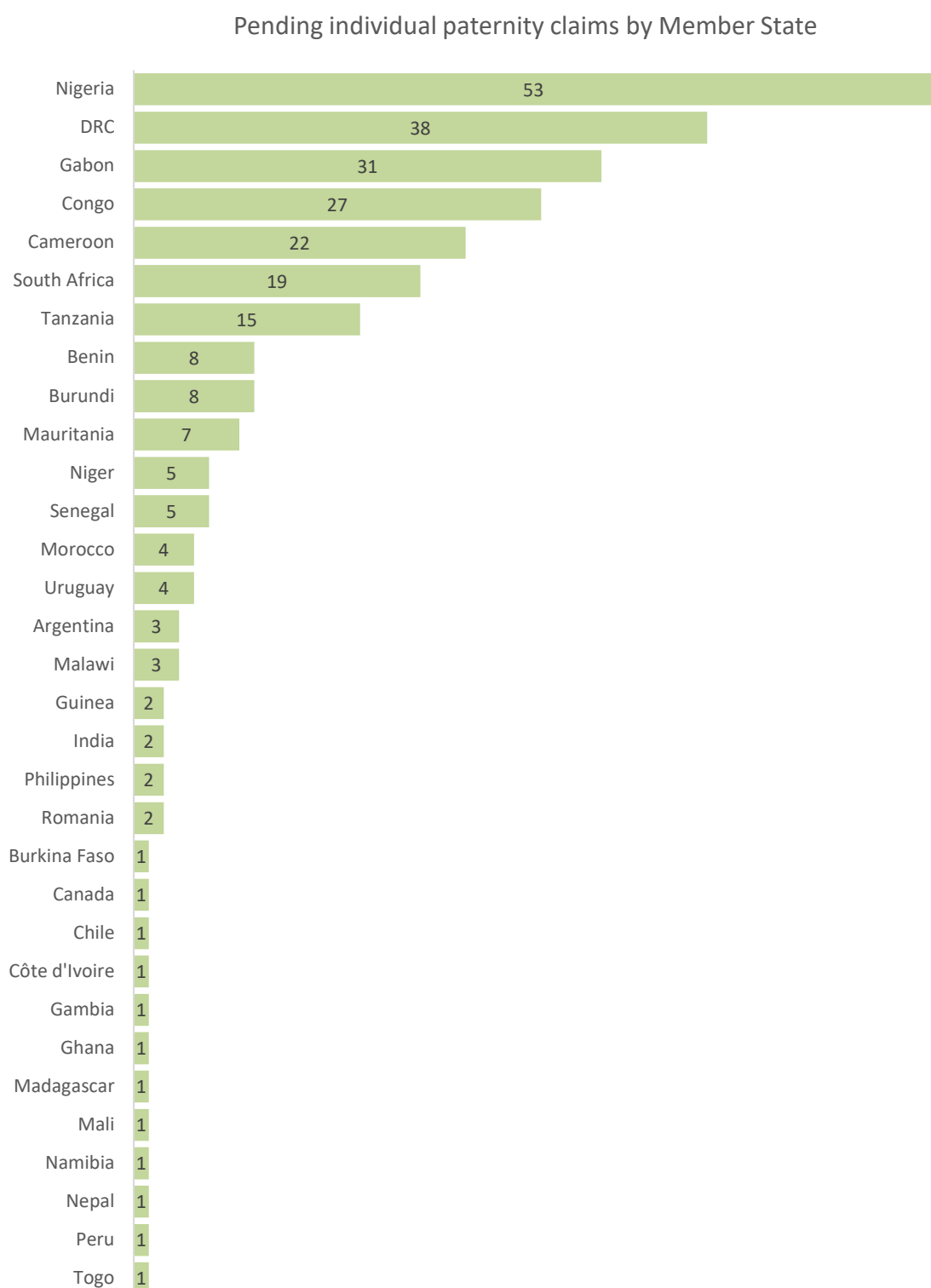
