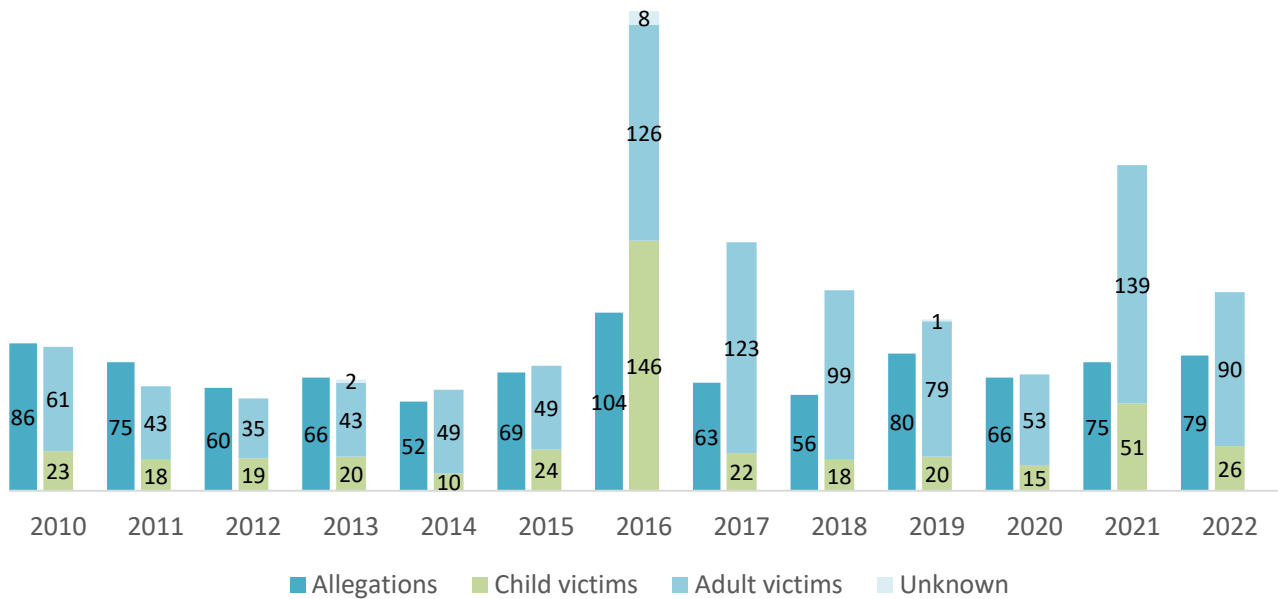

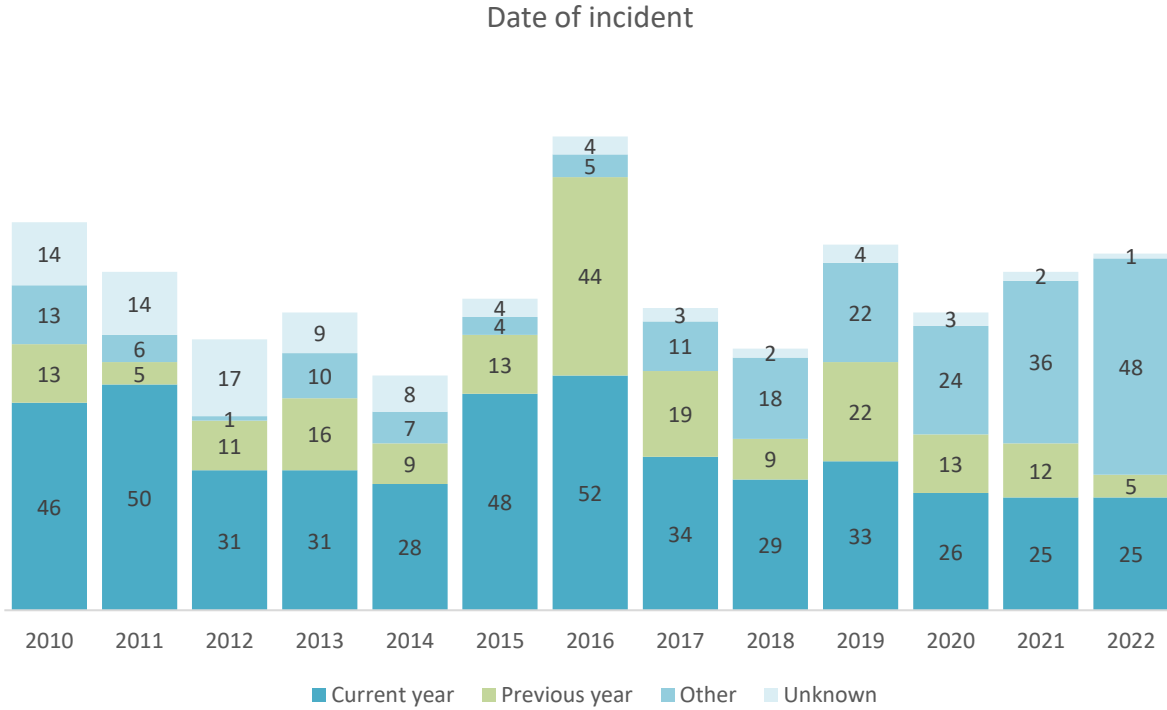

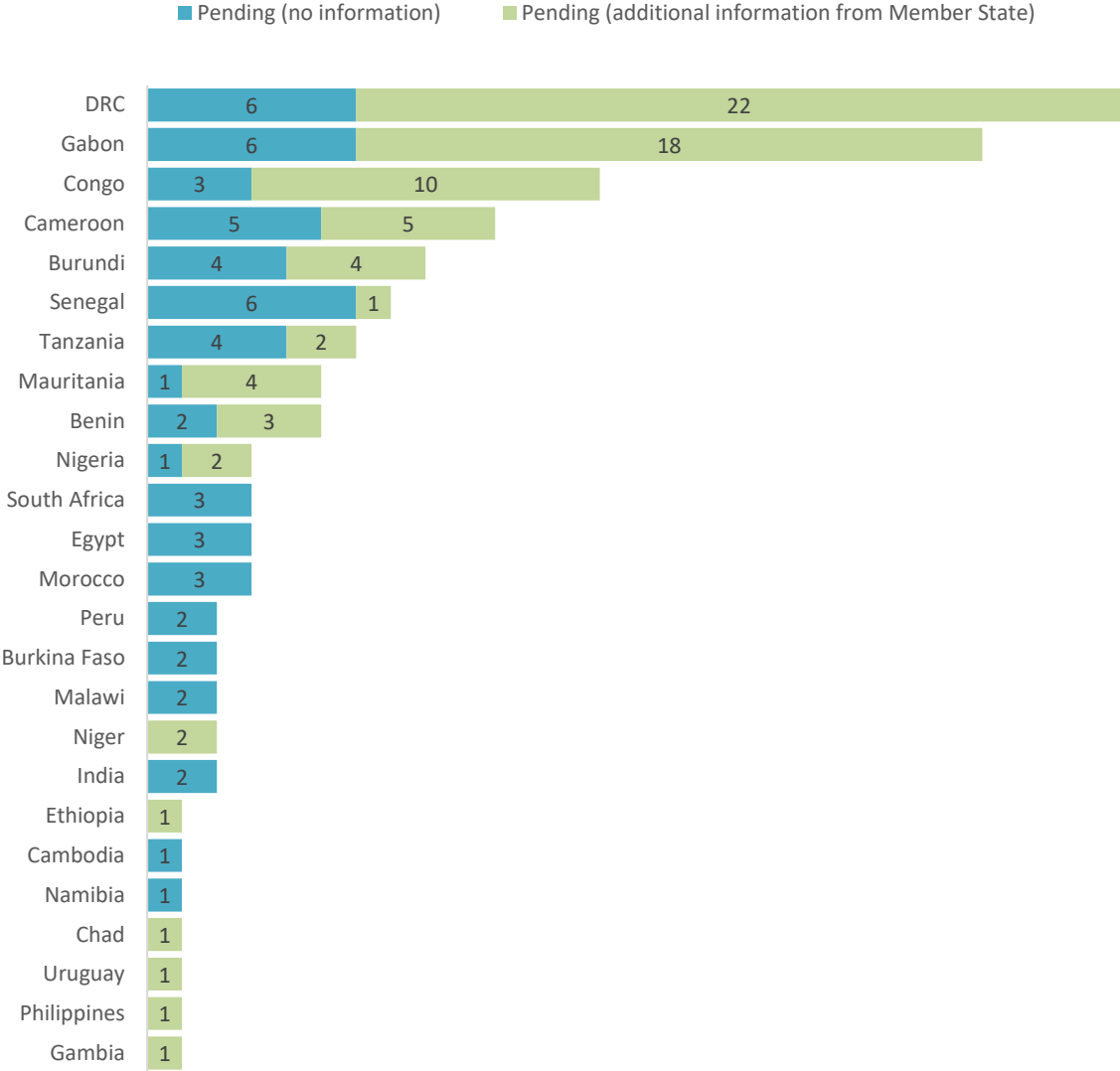

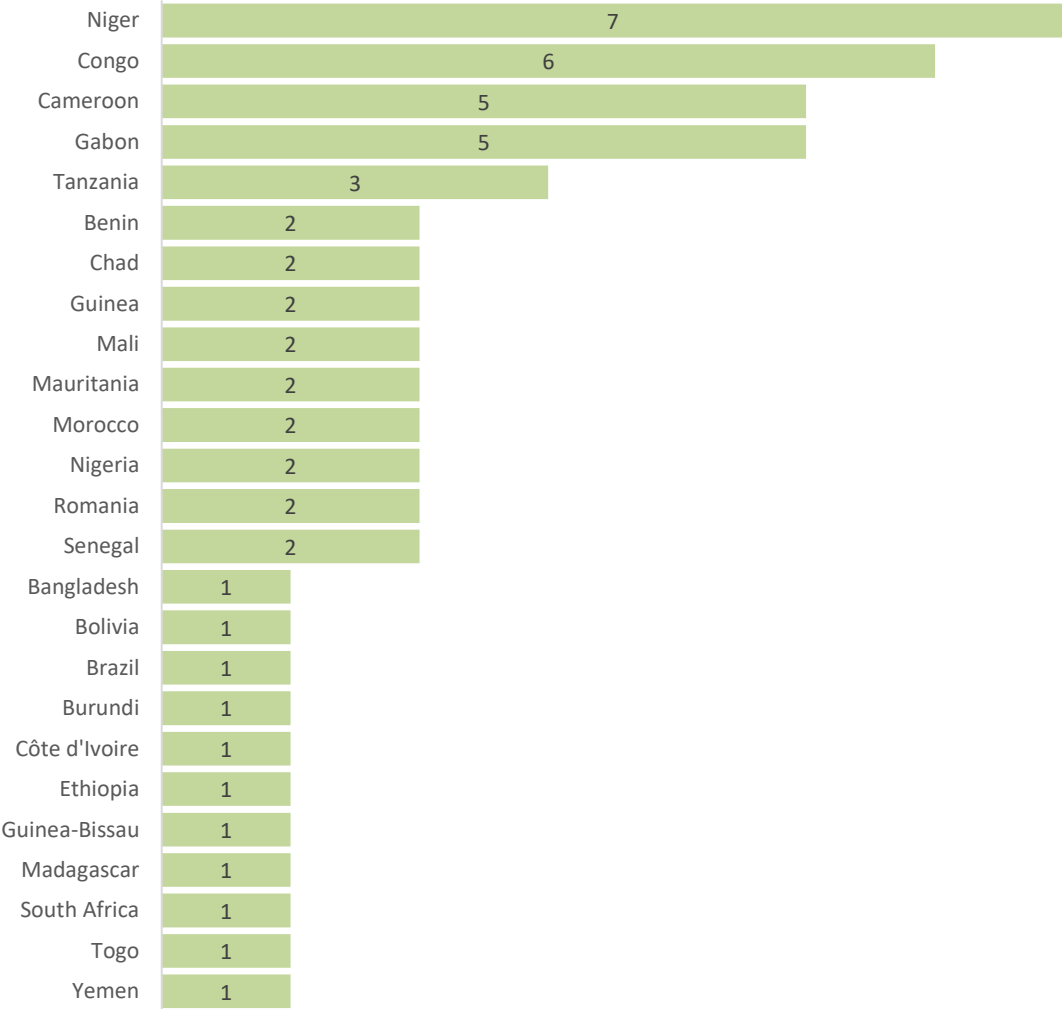
Pending investigations by Member State
